INSPECTION REPORT

IN PURSUANCE OF AN ORDER, received from **Messrs. PHILIPPINE ASSOCIATION OF FEED MILLERS/ UNAHCO, INC.**, we did, carry out the instruction summarized as below:

- Conduct Vessel Draft Survey (Initial) prior to and upon completion (Final) of the discharging operations.
- Attend on-board during the entire discharging operations, to include inspection of the cargo following the opening of the Vessel's cargo Holds and see to it that the cargo is properly stowed, taken into consideration any and all traces of Wet, Damaged, Contaminated as well as insect infestation, if any.
- Conduct inspection of all empty Barges/Vessel to ensure cleanliness and absence from any infestation or contamination.
- Conduct Barge/Vessel Displacement Survey of all Empty and loaded Barges/Vessel prior to and upon completion of loading operations to approximately ascertain the Cargo Weights loaded on board Barges/Vessel vis-à-vis the cargo weights discharged from on board the mother Vessel.
- Supervise and inspect all loaded Barges/Vessel prior to discharging of cargo at destination to see to it that all seals are intact and issue or tender the necessary letter or Reserve/Protest if and when said Seals are found missing and/or tampered. Monitor and record Cargo Outturns as received based upon the existing weighing system of the selected and/or accepted by all receivers, which shall be the basis for the computation of the Pro-Rata, in connection with the actual results of the cargo as received thereof.

The Feed Wheat in Bulk commodity was discharged from vessel hold number 1, 2, 3, 4 and 5 directly to receiving barges designated by each receiver using vessel's gears assisted by the port stevedoring company personnel.

During discharge of Feed Wheat in Bulk from the said holds, a barge measurement was performed by SGS to determine the estimated loaded weigh in each barge.

The loaded barges were towed and pass along the Pasig river up to NAWACO Terminal, of which we had the discharging operation from barges to trucks direct to consignee's and others are temporarily stored at NAWACO warehouse. Results were as follows:
